1. Collision Loss/Damage Insurance: This coverage is not available to Texas residents. Covers physical damage to a rental car, up to a maximum of \$40,000, which is caused by a collision, fire, storm, vandalism or theft and occurs during the rental period. This benefit is limited to car rentals of up to 45 consecutive days. Collision Loss/Damage Insurance is available for travel in the United States and most foreign countries. No coverage is provided for motor vehicles rented in Israel, Jamaica, Republic of Ireland or Northern Ireland.

2. 24-Hour Hotline Assistance is available from anywhere in the world and provided by our in-house, multi-lingual coordinators.
